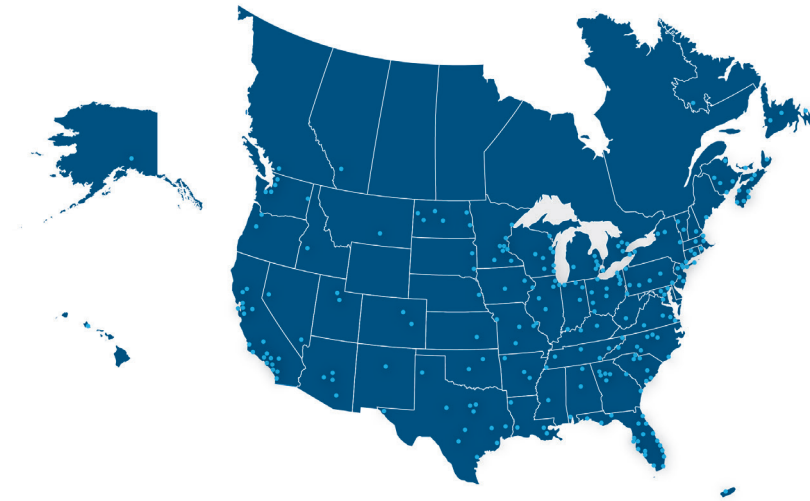
## OUR BUSINESS
